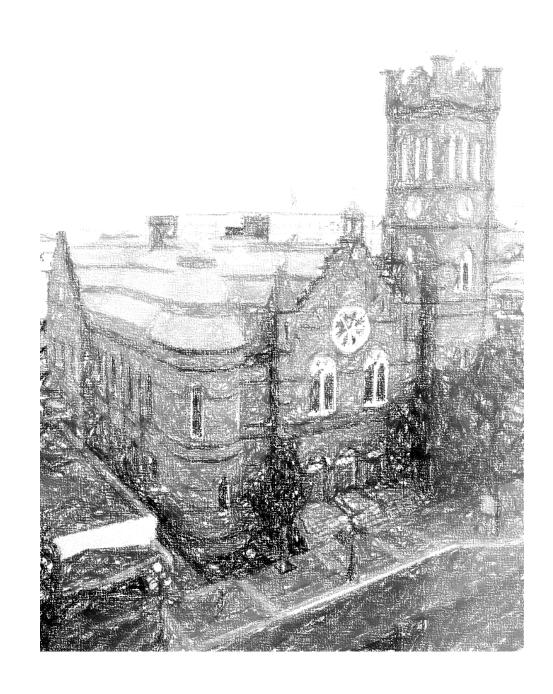

Treasurer's Report

The Congregation of St. Andrews ...each and every Member and Adherent, is to be commended for coming together and supporting the financial and Congregational needs of this community in 2013. In many respects, 2013 was a difficult year, and yet, the commitment and support by all of you made it a successful year. Our financial requirements continue to be met... albeit with some concern at times from your treasurer as we do still have a substantial shortfall. I am pleased to be able to present a summary of our financial position at the end of 2013.

I want to thank all those who work so diligently on a weekly and regular basis in fulfilling the operational tasks needed to keep our financial systems running smoothly. These tasks are looked after faithfully and I can assure the Congregation that this team works tirelessly to ensure the job is done right!

The 2014 budget, as approved by your Session is set out beside the 2013 results, and this will allow each of you to compare our budget vs. last year's performance. We have a challenging year ahead of us, and the 2014 plan allows for a full time Minister from July on. Of course that could change, and should that happen, I would then present a revision to both the Session and Congregation.

I would urge each member to carefully examine what level of financial support you can commit to keep this congregation vital and in good financial order. At present the costs to maintain St. Andrew's is about \$1000 per day. We have taken a number of steps to seek out other forms of income, and they are paying off. But we must ensure that we do not become totally reliant on those outside incomes. We must find ways to support ourselves without becoming too dependent on resources from outside the Congregation.

Consider what will be your level of financial support on a weekly or monthly basis, and seriously consider the PAR system to transfer that financial support. That system assures a predictable and regular financial support level, and relieves those volunteers mentioned above of a tremendous amount of weekly work... time that can be spent on other and potentially needler areas of personal involvement.

Financial review Report to the:

I have reviewed the Statements of the financial position of St Andrew's Presbyterian Church (Victoria), as at December 31, 2013 and the accompanying Notes and Schedules pertaining thereto. My responsibility is to express an opinion on the Financial Statements based on my review.

I have conducted the review in accordance with generally accepted standards. The review includes examining on test base evidence supporting the amounts and disclosures in the Financial Statements. Verification of envelope giving, donations and other revenues has been limited to amounts recorded. The review also includes assessment of the accounting principles used, as well as evaluating the overall Financial Statement presentation.

Search Committee

The search committee has been reviewing 13 profiles and have sent two requests for more information. The Rev. Dr. Victor expressed his thanks to Duncan Mackinnon for his willingness to chair the Search Committee.

Budget 2013

The budget reflects the following:

- That the Rev. Dr. Victor 's retirement at the end of May, 2013.
- A provision of \$20,000 for moving costs for a new minister.
- A three month allowance for the costs associated with a new Minister.
- A full year plan for our Assistant Minister, The Rev. Jennifer Geddes.
- An increase of 1.5% for our administration and property Staff.

We will continue to need our reserves to finance our operations. In 2012 we had several large gifts and as a result our draw on reserves was less than the amount budgeted for 2013.

We continue to be mindful of the need for congregational support to maintain salaries, services and programming at their present levels.

Ballet Victoria is responsible for approximately \$35,000 of the \$50,00 income generated by rental of our premises.

At present, Jack Reimer meets regularly with the CIBC team responsible for St. Andrew's investments. Fixed income instruments are becoming increasingly problematic as the economy changes. Our current investments are heavy weighted in bonds. In the near future Jack Reimer will be looking at changes to St. Andrews investment policy.

It was moved and seconded that the budget for 2013 be adopted as presented. Jack Reimer/David McLean. Carried.

Thanks were expressed for Jack's hard work and dedication to St. Andrews.

Committee Reports

It was moved and seconded that all committee reports be accepted as presented. Tom Shaffer/Peter Lewis. Carried

It was suggested that any committee member or members and adherents of St. Andrews who wish to make a comment about a report do so. The following comments and suggests were made.

Mission and Outreach

- It was suggested that the name Mr. Quarter be changed to Mr. Toonie.
- Annette Paradais and her team do a wonderful job of monthly outreach to approximately 350
 people at our Saturday morning breakfast.
- Christ Church Cathedral is appreciative of the monthly use of our facilities to host a Saturday morning breakfast.
- BC Ferries hosts a Saturday breakfast on the fifth Saturday of the month and continue to provide generous support through the United Way.
- David Buchanan attempt to get media coverage for the Saturday Morning Breakfasts has met little success.
- The Quilt and Knitting Group are always on the lookout for new members.
- The Annual Carol Sing has increased in popularity. We are now attracting up to 350 people for this popular advent event.

Christian Education

• Thanks were expressed to Dianne Penner for all her hard work in providing an interesting, and relevant education program for our Sunday School.

Worship

- Thanks were given to the hardworking ushering teams.
- John Mitchell has stepped down as chair of Worship. The Rev. Dr. Ian Victor expressed his thanks for John's dedication. John announced that he plans to work on a church directory over the next year.
- Dorothy Reimer announced that the choir is looking for new members. Some snow birds that have been attending St. Andrews have joined the choir for the time that they are in Victoria.

Congregational Life

- To provide two weeks for continuing education annually and at least the minimum allowance as set by the General Assembly.
- That the benefits of number 1 above shall be cumulative up to five years.
- To provide five weeks holiday annually.
- To pay pulpit supply during the periods of continuing education and holidays.

- In case of disability or extended illness, to continue to provide stipend, accommodation and allowances for a period not less than that set by the General Assembly, and to pay the cost of pulpit supply.
- To pay for Medical and Dental Insurance as provided through the Pension and Benefits Board of the General Assembly and to make contributions to the Pension Plan in compliance with the terms of the plan.
- To pay necessary moving expenses.
- Optional (such as book allowance, entertainment allowance, internet, cell phone, etc.).
